BUDGET & APPROPRIATION ORDINANCE

TOWNSHIP ORDINANCE No. HT2021-0614-ORD1

An ordinance appropriating for all town purposes for Homer Township, Will County, Illinois, for the fiscal year beginning April 1, 2021 and ending March 31, 2022.

BE IT ORDAINED by the Board of Trustees of Homer Township, Will County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Homer Township, be and the same are hereby appropriated for the town purposes of Homer Township, Will County, Illinois, as hereinafter specified for the fiscal year beginning April 1, 2021 and ending March 31, 2022.

SECTION 2: That the following budget containing an estimate and expenditures is hereby adopted for the following funds:

FOUNDERS CROSSING BOND FUND

FOUNDERS CROSSING GENERAL FUND

GENERAL ASSISTANCE FUND

OPEN SPACE FUND

PARK DEVELOPER CONTRIBUTION FUND

PARK FUND

TOWN FUND

SECTION 3: That the amount appropriated for town purposes for the fiscal year beginning **April 1, 2021** and ending **March 31, 2022** by shall be as follows:

Founders Crossing Bond Fund	<u>\$358,546.42</u>
Founders Crossing General Fund	<u>\$680,600.00</u>
General Assistance Fund	<u>\$89,478.00</u>
Open Space Fund	<u>\$1,061,701.59</u>
Park Developer Fund	<u>\$106,553.00</u>
Park Fund	<u>\$681,252.00</u>
Town Fund	<u>\$3,280,924.00</u>
TOTAL APPROPRIATIONS:	<u>\$6,259,055.01</u>

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2, constituting the total appropriations in the amount of **Six million two hundred fifty-nine thousand and fifty-five and one cent for FISCAL YEAR BEGINNING April 1, 2021 ENDING March 31, 2022.**

SECTION 6: That Section 3 shall be and is a summary of the Annual Appropriation Ordinance of the Township, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.


