f. Status on Hadley Road

Road Commissioner Porfilio, Assessor Maurella, and Supervisor Balich told Village that Homer Township is willing to take over the road. The mayor then announced that the Village is going to do it. If the Village is going to do it, then we will let them.

# 8. Highway Commissioner Report: Brent Porfilio

# a. Smith Road/Long Run Creek Bridge Replacement

The Phase I Engineering has begun and is scheduled to be completed in 2024. We are waiting for temporary bridge shoring options from the Phase I Consulting Engineer for stabilizing the bridge until construction which is not anticipated until 2025-2026

# b. 2023 Roadway Paving Program

The 2023 Roadway Paving Program has been completed by D Construction for the following streets -a final walk thru will be performed this month:

- Meader Road (Bruce Rd. to the S. limit of HT)
- Bruce Road (W/Meader Rd. intersection)
- Gougar Road (Bruce Rd. to N. Prairie Ridge sub.)

# c. 2023 Roadway Lighting Program

The 2023 Roadway Lighting Program is scheduled to begin in September and be completed this year. We will be investigating solar lights for locations where electricity is not readily available in 2024.

# d. 2023 Roadway Striping Program

The 2023 Roadway Striping Program is scheduled to be completed this month -a final walk thru will be performed upon completion.

#### e. 2023 Homer Township Highway Commissioner's Grant

We are still accepting applications for the 2023 HT Highway Commissioner Special Needs Grant for \$5,000. Applicant needs to be a HS graduate, and Homer Township resident. The HTRD Grant application can be filled in via the following Homer Township Highway Department link:

#### f. Muslim Ummah Cemetery

The access road/cul-de-sac and driveway serving this site have been completed, however HTRD has sent comments last month to the Owner of deficiencies in their driveway work in the HTRD ROW. The HTRD Site Access Permit remains valid, however only for addressing the driveway deficiencies.

# g. 2023-2024 Winter Salt

The HTRD has a 2-year contract for roadway blended salt which will continue thru this Winter. We have leftover salt from our previous mild winter and have an additional 300 tons available through the current salt contract for the upcoming winter.

#### h. Trantina Farm Clay Fill Project

We are waiting for the IEPA NOI to be processed so we can start back up with receiving more clay fill to be used for the future Community Center parking lot and grading. We have received ~2,000 CY thus far and are looking for another 2-3,000 CY from local projects to continue to fray costs for the development.
