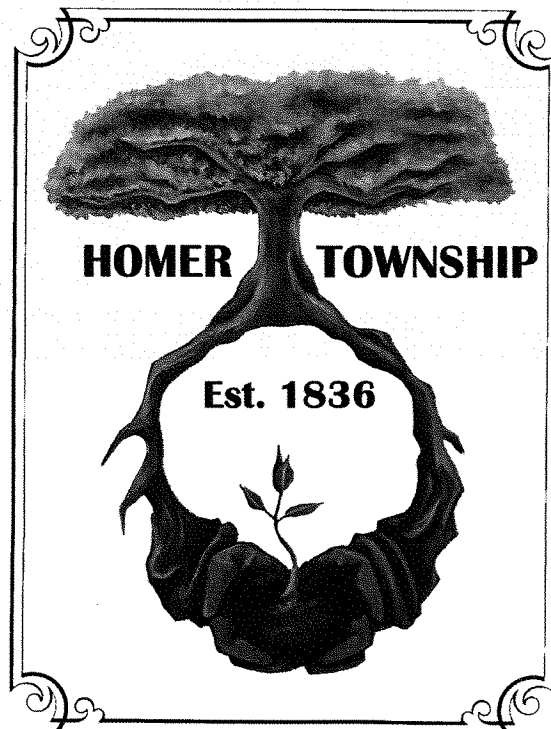

An ordinance levying taxes for all Town purposes for Homer Township, Will County, Illinois for the tax year 2023 collectible in 2024.

BE IT ORDAINED by the Board of Trustees of Homer Township, Will County, Illinois, as follows:

SECTION 1: That the sum of One Million Three Hundred Forty-Two Thousand Five Hundred Thirty & 00/100 (**\$1,342,530.00**) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for purposes as:

PARK FUND
DEBT SERVICE

for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
