

HOMER TOWNSHIP, WILL COUNTY, ILLINOIS
RESOLUTION 2024-0708-RES 1
SETTING COMPENSATION FOR TOWNSHIP OFFICIALS
FOUR YEAR TERM BEGINNING MAY 19, 2025

WHEREAS, according to 60 ILCS 1/65-20, the compensation of Township Officers shall be set by the Township board at least 180 days before the beginning of the terms of office;

WHEREAS, according to 60 ILCS 1/65-20, the compensation for the Road District Treasure shall be fixed by the Township Board and shall be not less than \$100 or more than \$1,000 per year;

WHEREAS, according to 605 ILCS 5/6-207, the compensation of the Highway Commissioner shall be fixed by the Township Board at an annual salary of not less than \$3,000 to be paid in equal monthly installment, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

WHEREAS, according to 35 ILCS 200/2-70, the compensation of the Township Assessor and Collector shall be set by the Township Board at the same time the Board sets the compensation of its Township Supervisor;

NOW THEREFORE, BE IT RESOLVED BY the Township Board of Trustees assembled at the July 8, 2024, meeting of Homer Township, Will County, Illinois that the compensation of the Homer Township Officials for the four-year term beginning May 19, 2025 and ending May 21, 2029 (January 1, 2026 – January 1, 2030) for Assessor and Collector) shall be as follows:

Section 1: The recitals set forth above are incorporated in the following tables and made part of this Resolution as if set forth fully herein.



Section 3: This Resolution shall be effective immediately upon the passage and approval by a majority of the Board of Trustees.
