# **TAX LEVY ORDINANCE HOMER TOWNSHIP**

## **ORDINANCE NO. HT2024-1118-ORD1**

An ordinance levying taxes for all Town purposes for Homer Township, Will County, Illinois for the tax year 2024 collectible in 2025.

**BE IT ORDAINED** by the Board of Trustees of Homer Township, Will County, Illinois, as follows:

**SECTION 1:** That the sum of One Million Three Hundred Forty Thousand Eight Hundred Five & 00/100 (\$1,340,805.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for purposes as:

GENERAL ASSISTANCE FUND  
PARK FUND  
DEBT SERVICE

for the year 2024.

**SECTION 2:** That the amount levied for each object and purpose shall be as follows:

**SECTION 5:** That this ordinance shall be in full force and effect after its adoption, as provided by law.


